

ELECTION OF COUNCIL MEMBERS for 2021 – 2023

NOMINATION OF COUNCIL MEMBERS

Dear SASAS member

The terms of office of some SASAS councillor members will be completed in the middle of 2021. Three councillors, Vice-President and President have to be elected for the next two year term. The election of SASAS council is determined by Clause 5 of the SASAS Constitution.

Members are invited to nominate candidates for the vacant positions on the SASAS council. A form for the nomination is provided on page 2 of this notice. Nominations must reach the Secretary by **5 July 21**. All nominees and nominators must have paid their membership fees for 2021.

Prof Maiwashe and Dr Nengovhela have indicated that they are not available for re-election. Prof Makgahlela is not eligible for re-election as a council member but is eligible for nomination in another position on council. Ms Snyman is eligible for re-election for a further term.

An electronic voting process through the SASAS website will be followed. Members (full, retired and honorary) who are registered for 2021 on the website, can cast their votes electronically.

This will take place from **2 – 6 August 2021**.

Paid-up members who have not registered on the website, will be able to cast a postal vote. However, since the RSA postal services are not very reliable, this will be done via e-mail, though confidentiality might be compromised. Members are therefore encouraged to rather register and vote, using the website.
